CONVENTIONS OF THE PAKISTAN JOURNAL OF FORESTRY

- The paper must be submitted in duplicate, typed at double spacing on white paper with liberal margin on one side, alongwith CD, USB Flash Drive (WordPerfect/MS Word in the software format) or sent via email attachment (on pfiesbranch@gmail.com). Graphs should be saved on a separate file.
- Words to be italicized in print such as scientific names in Latin, Latin phrases and abbreviations should be underlined singly in script.
- All biological names in Latin should be written with a capital for the generic name, a small for the specific name, and a capital for the author's name(s), e.g. *Podophyllum emodi* Wall. ex Royle, with no comma between the Latin name and the authority.
- The authority for a biological name in Latin should be quoted once only in the beginning. Thereafter only abbreviated generic name should be given, as far as it is permissible to avoid loss of identity.
- Anglicized biological names in Latin, whether abbreviated or not, common in local usage, should not begin with an initial capital and should not be underlined, e.g. dipterocarp, eucalypt.
- Local or trade name should be followed by a scientific Latin name with authority, enclosed within brackets, whenever it appears for the first time in the text, e.g., *D. sissoo*.
- Carefully constructed paragraphs should be employed and material accommodated in different sections-heads, subheads and subsubheads in small or capital letters, underlined or otherwise, as indicated in the style of distribution of heads.
- References should be listed in alphabetical order under the head "REFERENCES" and given in the form with small or capital letters as indicated there under.
- Inside the text, references should be cited by name(s) of the author(s) and year of publication, e.g. "Quraishi (1965)" or "by Quraishi (1965)" and citations should not be given in the form as "5" or "by Quraishi (5)".
- Multiple references should be written as Quraishi, 1963; Khan 1964 and Malik *et al.*, 1963.
- Line drawings, graphs and maps should be sparingly used and must fit in the page dimensions of PJF.
- Photographs should be on sharp glossy paper.
