## FORESTRY ABSTRACTS PUBLISHES ITS 250,000TH ABSTRACT

Forestry Abstracts, a CAB International abstract journal which covers all aspects of forestry, recently published its 250,000th abstract.

Provenance variation in blue spruce (*Picea pungens*) at eight locations in the northern United States and Canada is the title of the abstract which appears in the January issue of the 1987 volume, (Vol. 48) and refers to a paper written by B.C. Bongarten and J.W. Hanover and published in *Silvae Genetica*.

Forestry Abstracts began publication nearly fifty years ago in 1939. The number of abstracts published each year has steadily increased to approximately 7,500 in 1987.

Forestry Abstracts has three main sections:

- News with brief notes of recent notable findings and forthcoming events. Occasional issues also include full-length review articles.
- 2. Abstract arranged into groups dealing with General Publications and General techniques; General Aspects of Forestry; Silviculture; Forest Mensuration and Management; Physical Environment; Fire; Plant Biology; Genetics and Breeding, Variation, Evolution; Mycology and Pathology; Insects and Other Invertebrates; Range; Game and Wildlife; Fish; Protection Forests, Watershed/Catchment Management, Soil Conservation; Other Land Use, Nature Conservation, Arboriculture; Dendrochronology and Dendroclimatology.

## 3. Author and subject indexes

Over 14,000 primary journals are scanned by CAB International staff to select publications for the abstracts section. In addition, books, theses, conference proceedings and reports are also included in *Forestry Abstracts*. English abstracts are prepared for all publications. About 60% of the publications are originally published in English and 40% are published in other languages. CAB International staff routinely can publications in more than 50 different languages.
