*No. WL and FT(DCF-GEN-93)/76 dated 29th July, 1976.* In exercise of the powers conferred by the proviso to sub-section (3) of section 14 of the Sind Wildlife Protection Ordinance 1972 (Sind Ordinance V of 1972) the Government of Sind are pleased to permit cultivation of land within the limits of the Kalri (Keenjar), Hudero and Haleji Game Sanctuary declared as such, vide Notification No. WL&FT(DCF-GEN-81)/75, dated July 17, 1975 for aesthetic enjoyment of betterment of scenery and for the purposes of such cultivation or matters incidental thereto allow people to enter into and reside in the Sanctuaries.



No. *WL and FT (DCF-GEN-9/76-94*.—In exercise of the powers conferred by the proviso to sub-section (3) of section 14 of the Sind Wildlife Protection Ordinance, 1972 (Sind Ordinance V of 1972), the Government of Sind are pleased to permit cultivation of land within the limits of the Mahal Kohistan and Hab Dam Game Sanctuary declared as such, *vide* Notification No. *WL&FT(SOI-DCF-992)/74*, dated January 31, 1974, for aesthetic enjoyment or betterment of scenery and for the purposes of such cultivation or matters incidental thereto allow people to enter into and reside in the Sanctuaries.

No. *WL and FT (DCF-GEN-153)/76* dated the 13th August, 1976. In exercise of the powers conferred by Section 39 of the Sind Wildlife Protection Ordinance, 1972 (Sind Ordinance V of 1972) the Government of Sind are pleased to allow Mr. Obaidullah Baig of Pakistan Television Corporation to collect, except from the Game Sanctuaries, not more than two species of each birds, mammals and reptils mentioned in the first schedule to the said ordinance by shooting or trapping in Sind Province for public purpose *i.e.* making of documentary film, from 15th August 1976, to 28th February, 1977.
