In exercise of the powers conferred by the proviso to sub-section (3) of section 14 of the Sind Wildlife Protection Ordinance 1972 (Sind Ordinance V of 1972) the Government of Sind are pleased to permit cultivation of land within the limits of the Kalri (Keenjar), Hudero and Haleji Game Sanctuary declared as such, vide Notification No. WL and FT (DCF.-GEN-81)/75, dated July 17, 1975 for aesthetic enjoyment or betterment of scenery and for the purposes of such cultivation or matters incidental thereto allow people to enter into and reside in the Sanctuaries.
