In exercise of the powers conferred by section 39 of the Sind Wildlife Protection Ordinance, 1972, (Sind Ordinance V of 1972) and in supersession of this Department Notification No. 5(27)SW & FT/72, dated 3rd January, 1973, the Government of Sind are pleased to allow Mr. Dr. I.U. Baqai, Principal Investigator, Wildlife Research Project, University of Karachi to collect except from the Game Sanctuaries birds, reptiles and mammals (except those shown in Second Schedule to the said Ordinance) by shooting or trapping in Sind Province for scientific Purpose.

No. WL&FT(S.O.I.)2(2)/74, dated 2nd April 1975. No. WL&FT DCF-GEN-1404)/75, dated 28th April, 1975. In exercise of the powers conferred by Section 41 of the Sind Wildlife Protection Ordinance, 1972 (Sind Ordinance V of 1972), the Government of Sind are pleased to make the following amendments in the Sind Wildlife Protection Rules, 1972, and to direct that the said amendments shall take effect on and from 11th November 1973:—

1. In rule 2, after clause (a) the following clause (aa) shall be inserted:-
“(aa) ‘Ordinance’ means the Sind Wildlife Protection Ordinance, 1972”;
2. After rule 7 the following rule 7-A shall be inserted:-
“7-A The Game Wardens shall have full powers of granting rewards, out of sum accepted as compensation for the offences registered under the Ordinance not exceeding 1/4th of the total amount realised”.
